
As some of these exhibits are narcotics and weapons, the disposition of which necessitates special handling, the Clerk is directed to notify the agency which originally entered the narcotic and/or weapon exhibit into evidence to arrange for their collection and destruction.

Agencies so notified by the Clerk will receipt for the contraband exhibits transferred to them by the Clerk and will dispose of the exhibits, as appropriate, forthwith. Accordingly, it is

ORDERED that the contraband exhibits identified on the attached list, originally submitted by and still carried on the property records of the Memphis Police Department, be removed from the Clerk's custody and destroyed.
